### SHARPENING OUR TOOLS AGAINST VIOLENT EXTREMISM

Violent extremism has become an increasing internal and international security concern with the shift of terrorist threats from organised groups to individuals who are harder to detect and whose actions are harder to predict.

On January 29 a high-level conference was held in Brussels based on the work of experts and practitioners in the Radicalisation Awareness Network. Among policy proposals highlighted include the need for training local police to detect signs of radicalisation into violent extremism, and providing de-radicalisation or exit programs for members of extremist groups. > More

# EUROPEAN COMMISSION STRENGTHENS THE PROTECTION OF THE EURO BY MEANS OF CRIMINAL LAW

Counterfeiting of the Euro is estimated to have cost at least €500 million since the currency was introduced in 2002. The proposal aims to strengthen the protection of the Euro and other currencies against counterfeiting through criminal law measures. These include strengthening cross-border investigations and introducing minimum penalties, including imprisonment, for the most serious counterfeiting offences. ► More
